

ISRAEL TRIP APPLICATION FORM (USA departures)

Dates: March 10-22, 2023

Cost: \$2,995* USD per person including airfare from JFK and mandatory travel insurance

Note: applications for enrolled WOLBI students will be given priority until October 10, 2022.

By signing this, you agree to all of the following. Please read carefully!

- This trip is reserved exclusively for WOLBI students, alumni, and staff.
- Your signature below constitutes a commitment to participate in the Israel trip at your expense.
- This is NOT a ministry trip but rather a personally-funded enrichment trip. As such, tax-deductible donations cannot be raised in the name of Word of Life to cover its cost.
- If you are an enrolled WOLBI student, the cost of this trip cannot be added to your student bill. Students with large outstanding balances on their student bill may be denied participation in the trip.
- A \$300 non-refundable reservation fee will be payable to Word of Life no later than **November 25, 2022**. This will be applied to the cost of the trip. Half the remaining cost (\$1350) will be payable to Word of Life no later than **January 13, 2023**. This installment is NOT reimbursable due to the airline seat being then committed. The remaining balance (\$1345) will be due no later than **February 3, 2023**. This installment may be reimbursed up to two weeks before departure. All payments can be made in cash, check to *Word of Life*, or credit card at www.wordoflife.edu/payments. Select US BI and then "Israel Trip - BI".

- Space is limited and all applications will be honored on a first-come, first-served basis upon receipt of the \$300 reservation fee. Word of Life staff and alumni may apply at any time, but enrolled WOLBI students will be given priority until October 10, 2023 as noted above. Once space has been filled, applicants will be placed on a waiting list. Reservation fees will be reimbursed to any applicant who is declined due to a lack of space.
- This trip departs JFK airport (New York City) at 1:30pm on Friday, March 11, 2023. Transportation to JFK is the responsibility of trip participants and is NOT included in the cost of the trip since this date falls in the middle of the spring break. For students studying at the NY campus, transportation will be provided from JFK back to the campus on Wednesday, March 22, 2023 at no additional cost.
- A passport with an expiry date no earlier than September 30, 2023 will be required by **January 10, 2023**. This is the responsibility of all trip participants and is NOT included in the cost of the trip.
- Any classes missed due to participation in this trip must be made up upon the student's return.

COVID-19 INFORMATION

The following information applies to all trip participants, regardless of their point of departure, and reflects what is in effect as of this writing. Changes beyond the control of Word of Life are possible.

- Being vaccinated against Covid-19 is NOT required to enter Israel.
- Travel insurance that covers medical treatment for Covid-19, including potential mandatory isolation, is required. This insurance is included in the cost of the trip. See [here](#) for a full description of coverage. Optional trip cancellation and interruption insurance may also be purchased. See details below.
- Covid testing is not required prior to departure nor upon arrival in Israel.
- An online [Entry Form](#) must be completed within 10 days of departure to Israel.
- When leaving Israel, an exit statement is NOT required. Covid-testing will depend on the requirements of the country to which you are returning. The cost of any testing will be the responsibility of trip participants. If a large number of trip participants require testing, we will arrange for group testing at our final hotel at a discounted price (approximately \$25-50 depending on the type of test required).
- Masks are not required in any of the locations that we will visit in Israel. Masks may be required by some airlines.

Trip cancellation policies

- If the trip is cancelled by Word of Life prior to November 29 due to unforeseen Covid-19 restrictions or safety concerns, all funds will be reimbursed including the reservation fee.
- If the trip is cancelled due to unforeseen Covid-19 restrictions or safety concerns which cause the airline to cancel our flights to Israel, the airline portion of the trip cost will become available for reimbursement. We will then do our best to secure the greatest possible reimbursement of the rest of the trip cost. The reservation fee will remain non-refundable.
- If a trip participant must cancel due to testing positive for Covid-19 prior to departure, we will do our very best to replace them with someone on the waiting list. If this is possible, a full reimbursement will be made including the reservation fee. If this is not possible, we will do our best to secure the greatest reimbursement that we can. The reservation fee will remain non-refundable.
- PLEASE NOTE: Trip participants flying with us from JFK may purchase optional **trip cancellation and interruption insurance** until February 15 at a cost of \$150. Please note this when completing the application form. See [here](#) for a full description of coverage.

If a dispute over this agreement or any claim for damages arises, the Participant agrees to resolve the matter through a mutually acceptable alternative dispute resolution process.
